## **Prior Authorization Changes – Effective 01/15/18**

Effective 01/15/18, DentaQuest will be adding prior authorization and prepayment review to additional procedure codes.

Prior authorization will be added to the following procedure codes for **TX HHSC Medicaid** and **CHIP**. Procedure codes must be <u>prior authorized before</u> rendering treatment. Failure to do so will result in a denial of services.

All codes **except** D9248 will require narrative and pre-operative x-rays be submitted with the prior authorization request.

**D9248** will require the following be submitted with the prior authorization request:

- 1. Documentation of the reason for non-iv conscious sedation---member specific
  - a. narrative indicating patient behavior issues in office or referral to pediatric dentist due to behavioral issues (should be supported by information regarding prior attempt dates and provider)
  - b. dated documentation of failed local, failed nitrous, or narrative if inability to anesthetize due to infection/abscess
  - c. documentation of underlying medical condition, developmental/physical disability or special needs that make local anesthesia ineffective or unattainable
- 2. Patient specific narrative of scope of proposed treatment—ideally tooth by tooth and/or photographic/radiographic documentation to support extent of proposed treatment
- 3. Patient age

DentaQuest will begin accepting prior authorization requests for dates of service on or after 01/15/18 on 01/10/18.

# **Pre-Payment Review Changes – Effective 01/15/18**

Pre-payment review will be added to the following procedure codes for **TX HHSC Medicaid** and **CHIP.** Services that require pre-payment review will be subject to retrospective review. These services can be rendered before determination of medical necessity, but require submission of proper documentation (as indicated in the "Documentation Required" column of the ORM) with the claim form.

All codes will require narrative and pre-operative x-rays to be submitted with the claim.

## **Credentialing Reminders**

DentaQuest would like to remind all providers that the information submitted to DentaQuest for credentialing must match the enrollment records with TMHP. Credentialing will not be completed until any discrepancies are addressed. For example, if you want to enroll with DentaQuest under a business NPI, that NPI must be enrolled with TMHP as well.

In addition, recredentialing must be completed in a timely manner. Failure to do so may result in being removed from the network and having to reapply for consideration.
